MEMBERSHIP CATEGORIES GOLF COURSE ACCESS INFORMATION

CATEGORY: A – Voting Member

May play *any time* the course is available. Access to all Member events.

CATEGORY: B – Voting Member

MONDAY - FRIDAY: May play *any time* the course is available.

SATURDAY, SUNDAY, & any HOLIDAYS: May tee off starting *at* 11:30 a.m.

NOTE: *effective during daylight savings winter hours, a "Category B" member may tee off starting at 10:30 a.m. on SATURDAY, SUNDAY, & HOLIDAYS.*

FAMILY – A & B Voting Members

A Family Membership designates one adult family member as the Category A member and the other adult as the Category B member. Any children/dependents covered in a Family Membership are considered FRCC Junior Members.

AGES 19-26 - Members must provide proof of age to qualify.

May play *any time* the golf course is available. Access to all Member events.

AGES 27-39 – Voting Member - Members must provide proof of age to qualify.

May play *any time* the golf course is available. Access to all Member events.

COLLEGE - Proof of age and college enrollment required. Must apply yearly.

May play *any time* the golf course is available. Access to all Member events.

JUNIOR – 18 & under Proof of age required. Must apply yearly.

MONDAY - FRIDAY: May play *any time* the course is available.

SATURDAY, SUNDAY, HOLIDAYS: May tee off starting at 1:00 p.m. OR 12:30 p.m. if accompanied by an adult member.

SOCIAL GOLF

MONDAY - FRIDAY: May play *after 10am*.

SATURDAY, SUNDAY, HOLIDAYS: May begin play starting *at* 12:30 p.m.
Green fee 18 Holes - \$40. Green fee 9 Holes - \$20. Carts are optional.

Golf Course and Practice Areas Dress Code Policy

Effective: April 1 to November 15

Men: Acceptable attire: golf slacks, shirts with collar and sleeves, turtle necks, mock turtle necks, shorts which are lower than mid-thigh length, sweaters and jackets

Women: Acceptable attire: golf skirts/ skorts, slacks, shorts with proper length, proper golf shirts, blouses, turtle necks, mock turtle necks, sweaters and jackets

The following items of clothing are not permitted: Jeans (including any denim), sweat pants, workout attire, work uniforms, tank tops, tee shirts, camouflage hunting clothing, short-shorts, cut-off shorts, cargo shorts greater than 3/4 length.

Members are responsible for their guests following the dress code of Fall River Country Club. If any golfer is improperly dressed, they will be denied access.

Clubhouse Dress Code and Cell Phone Policy

The following items are NOT permitted in the dining rooms at any time: sweat pants, workout attire, work uniforms, tank tops, tee shirts, camouflage hunting clothing, short-shorts, cut-off shorts, cargo shorts greater than 3/4 length.

Men's shirts must have a collar or an approved mock turtleneck. No short-shorts or cut-off shorts.

Jeans are allowed (must be in good repair and men must wear collared shirts) in the CLUBHOUSE. During formal member events, proper dress is required, no jeans.

Hat Policy: Caps shall not be worn at any time in the clubhouse (except in the Pro Shop, Locker Room and Lower Lounge).

Cell Phone Policy: Inside the clubhouse, cell phones must be placed on vibrate only – no ringers. All calls must be taken out of the dining and bar areas.

4. I agree that if I am elected to Membership, this Membership can be transferred or assigned only by me in the manner and with the limitations set forth in said By-Laws.
5. I agree that my Membership in and use of the Club may be terminated in the manner set forth in said By-Laws without terminating my dues obligation upon my failure to pay all financial obligations due from myself to the Club as they fall due or upon violation on my part of any provisions of the By-Laws of the Club.

Policy of the Fall River Country Club Regarding Delinquent Accounts

Adopted by a vote of the Board of Directors February 23, 2004 as amended March 22, 2004, January 27, 2005, June 20, 2011, April 1, 2014, November 28, 2016 and January 27, 2020.

WHEREAS, for the benefit of the membership, the Fall River Country Club requires all of its members to timely pay all charges to their accounts, including, but not limited to, dues, assessments, greens fees, golf cart rentals, restaurant and bar charges, pro shop charges and purchases, and any other club charges. All Member account charges are due by thirty (30) days from the date of billing. An interest charge of 1½% per month will be added to delinquent balances.

1. The Business Office of the club will review all member accounts, within five (5) business days after the end of each month. A letter will be sent to the member of each delinquent account. The letter (Exhibit A) will state the amount needed to make the account current. The member will also receive a courtesy call or an email from the office to remind them of the past due amount. The member will have ten (10) days from the date of the letter to make payment.
2. If a satisfactory payment is not received by twenty (20) days from the date of the first letter, the Business Office will send a final notice (Exhibit C). At this point, the member will be considered suspended from the club. The Office Manager will inform the Club Manager, Treasurer, and President, when a member has been suspended.
3. A member who has been suspended, shall be prohibited from entry to the grounds and property of the club, and shall be prohibited from the use of any and all club and course facilities until such time as the delinquency is cured by payment in full. Once a member has been suspended, they will not be able to play in tournaments for the entire golf calendar year. A member who is suspended during a golf calendar year will also be suspended from tournament play the following golf calendar year.
4. The name of any suspended member shall be posted in a conspicuous place within the clubhouse and remain posted until said delinquency is cured by payment in full.
5. If the member's delinquent account is referred to collection, then the cost of said collection, including, but not limited to, reasonable attorney's fees, litigation expenses, interest at eighteen (18%) percent per year, and court costs shall be added to the amount owed by the member.
6. If a member's delinquent account is referred to collection and remains unpaid within 10 days of the entry of final judgment, then the member will be deemed to have resigned from the club, without further notice either from the member or from the club.
7. No changes in membership status or category requested by a member, including resignation, shall be considered by the Board of Directors if a member is delinquent.

This policy shall not affect the obligation of immediate and full payment of other club financial obligations as are reflected in the Bylaws.
